Synopsis: This proposed procurement is Small Business Set Aside, NAICS 238910 with a size standard of \$13,000,000.00.

Contractor shall furnish all labor, material and equipment necessary to remove and dispose of the existing 32,000 gallon bottled steel, water storage tank in Mineral County, WV in accordance with the statement of work included in the request for quotations bid package. All responsible sources may submit a bid which shall be considered by the agency. The solicitation will be provided in an electronic format, free of charge, to all registered plan holders.
