### C. SIGNIFICANT NEXUS DETERMINATION

Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.



of standing water. Stormwater is directed to the site from Middletown Road. The area of standing water is located within a depressional area and surrounded by trees. There are no wetlands or other streams located on this parcel. The ponded area does not have an outlet to another tributary and no overland sheet flow was observed or identifiable characteristics found. There was a change in elevation, created by Old Middletown Road which the likely outfall would be; however, there was no culvert or storm drain at the location. It was determined that the pond was an isolated open water which is not regulated by the Baltimore District Corps of Engineers.

Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
