connection, surface flow or other hydrologic connection to any other jurisdicational waters of the United States was observed during the Corps site review. The Corps has determined that two isolated wetland systems are present at this site. In the State of Maryland, isolated waters are not Federally regulated because of the Wilson Case. That is 33 CFR 328.(a)(3) has been removed from Corps regulations in the Fourth Circuit. Therefore, the isolated wetlands at this site are not Federally regulated.

The surface drainage feature identified in the area of review is a non-jurisdictional erosional feature produced by periodic discharges of stormwater from the surrounding development. The drainage feature is discontinuous within and downslope of the area of review. The feature does not have a continuous OHWM, bed and bank, or other morphological development that would suggest sufficient flow, volume or duration to be a jurisdictional water of the U.S. The Corps has determined that this drainage feature is non-jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW).
