Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The Corps conducted a field review on April 19, 2021, and a desktop analysis on September 20, 2022. During the reviews, one paulstrine forested wetland (Feature "E") exhibiting all three wetland indicators and four ephemeral features (Features "H", "I", "K" and "L") were identified. Wetland Feature "E" was located near the eastern

portion of the Corps Area of Review (AOR). During the Corps site visit and desktop analysis, it was determined that Feature "E" was constructed in uplands for the purpose of stormwater flow and retention. Further, there was no evidence of a connection surface flow or other hydrologic connection from the wetland feature to other waters of the U.S. Therefore, the palustrine forested wetland, Feature "E"is determined to be a non-Federally regulated, isolated water. Four ephemeral Features "H", "I", "K," and "L"were located near the northeastern portion of the Corps AOR. During the Corps site visit and desktop analysis, it was determined these features, "H", "I", "K," and "L", were constructed in uplands for the purpose of stormwater control. Based on aerial imagery and the NRCS Web Soil Survey, these features were constructed in upland soils and are considered pre-amble waters, ditches or swales excavated in uplands. Therefore, these features are determined to be non-jurisdictional, non-Federally regulated, isolated waters. Within the Fourth District states, that includes Maryland, isolated waters are not Federally regulated due to the United States v. James J. Wilson case. That is, 33 CFR 328.3(a)(3) has been removed from the Corps regulation in the Fourth Circuit. In conclusion, the PFO wetland, Feature "E" and four ephemeral features "H", "I", "K" and "L" at this site are not Federally regulated.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
