Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Area B is located on the south side of the property in an upland vegetated swale. During the site visit there was no surface water present or signs of saturation in the swale, and no hydrologic indicators as described in the Coastal Plain Regional Supplement. There were no hydric soil indicators present in the swale. Finally, the swale did not exhibit an ordinary high water mark.

Area C is located on the south-east side of the property adjacent to the intersection of Admiral Cocharan Drive and Route 2. The Soils Survey mapping for Anne Arundel County identifys the soils as "Collington and Annapolis Soils", a non-hydric soil, in Area C. The NWI Mapping does not show wetlands present in Area C. The USGS map does not show hydrologic features or streams present in Area C. No streams were observed flowing into the storm water management (SWM) facility, and the SWM facility is not an impoundment of waters of the U.S. Therefore, based on this information, the Corps has determined that the SWM facility was constructed in uplands, and is not a waters of the U.S.

#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.


