The forested area provides ample coverage for wildlife and aquatic species' habitat. In addition the large wetland complex provides a large area that will allow for flood storage and infiltration of water to help recharge ground water. The infiltration and the movement of the water through the complex will help reduce pollutants in the waterway. The wetland located onsite and part of the largest complex has a significant nexus with Zekiah Swamp Run, and RPW.

Summarize overall biological, chemical and physical functions being performed: **The proposed wetland complex is located adjacent to commercial facilities and there attendant features. The wetland complex will provide infiltration, pollution reduction, and flood control.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
