- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The area of review is an approximately three-acre former quarry site excavated in uplands. After the quarry operations were discontinued, the quarry was allowed to fill with ground water. Such areas are not generally considered "Waters of the United States" in accordance with 33 CFR 328.3. Also, the area of review is not contiguous with or to any water bodies, although the Gwynns Falls, a perennial stream, is within approximately 150 feet of the site. The Corps has determined that this is an isolated waterbody, in addition to being a feature originally created from uplands. No evidence of a connection, surface flow or other hydrologic connection to any other jurisdictional water of the United States was observed during Corps site review on April 8, 2014. In the State of Maryland, isolated waters are not Fedreally regulated due to the Wilson Case. That is, 33 CFR 328.(a)(3) has been removed from Corps regulations in the Fourth Circuit. Therefore, this isolated waterbody, originally created in uplands to obtain sand and gravel, is not federally regulated.**

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
