This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** [Site visit revealed that the area within the Limits of Disturbance \(LD\) was entirely upland dominated by hemlock, yellow birch, muscle wood, white pine and witch hazel. The soils were sandy and had a predominant color of 10 YR 4/3 or 7.5 YR 4/3 for the upper 6-7 inches and 7.5 YR 3/3 below for 7+ inches. There were no concentrations in any soil profile and no evidence of hydrology. There was a swale that ran through the LD towards a lagoon just offsite. The swale was manmade and was used to flush sediment and Iron from the intake water at the water treatment plant. This water would infiltrate in the sandy soils before it reached the lagoon. No hydric soils or hydrology were found in the swale.](#)
