Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The Corps conducted a field review on March 22, 2013. During that review, five areas [PEM-5, 6, 7, 8, 9] totalling 0.42 acre exhibiting all three wetland indicators were identified within the area of review. These areas are not contiguous with any water bodies. No evidence of a connection, surface flow or other hydrologic connection to any other jurisdictional waters of the United States was observed during the Corps site review. In the State of Maryland, isolated waters are not Federally regulated because of the Wilson case. That is, 33 CFR 328.(a)(3) has been removed from Corps regulations in the Fourth Circuit. #### C. SIGNIFICANT NEXUS DETERMINATION
