B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

1. **Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D: The three ephemeral channels on the site are approximately 6 feet wide. There is some sorting of bed material and some substrate sorting. The following geomorphology was absent: depositional bars or benches, braided channels and grade controls. There were no citations of crayfish, fish, snails, amphibians or wetland vegetation in the channel due to the lack of baseflow. The ephemeral channels are located, for the most part, within forested areas.
Aquatic Life (Organisms): There was no aquatic life or indicators of aquatic life within the channel. Due to the lack of a base flow. There was also no flow in the channel during the site visit.
Habitat for Wildlife: A detailed assessment of the quality of wildlife habitat was not performed. The channel may provide habitat for a variety of upland wildlife species.
Support Nutrient Cycling: The area of review supports nutrient cycling. The riparian forested corridor manages the nutrients from the adjacent forested land. The deciduous forest also inputs detritus into the channel but in very small amounts due to the channels being ephemeral in nature.
Sediment Transport: All channels carry sediment from forest runoff as well as the eroding banks and the drainage pattern through the upstream properties. The natural stream bottom has downcut over the years. The streams maintain the capacity to transport sediments from the abutting forest.
Pollution Trapping: There is a very small opportunity for the streams to perform this function. It is limited due to the relatively small area and reach of the ephemeral stream channel.
Water Quality Improvements: The channels do have vegetative cover to trap and uptake pollutants. The abutting forested uplands filters some runoff.
Temperature: There is a vegetative cover on the site that could help control and maintain the temperatures of the stream.
Flood Storage: There is some opportunity for the ephemeral streams to provide this function. One of the channels has downcut tremendously with steep almost vertical slopes. Therefore, there is very little potential for flood storage in this channel which has cut down approximately 6-8 feet.
Groundwater Discharge: This function was not confirmed in the field. There is little opportunity for the stream to recharge the groundwater system due to the short length of the stream and the lack of pools and ponding in the channel.
Groundwater recharge: These channels do not store enough water to slowly release it for groundwater recharge. The small size of

this channel and contributing drainage area would not contribute ample groundwater recharge.

Commerce: These three ephemeral channels, on private property, have limited recreational opportunities because of its small size and lack of baseflow. It does flow into a TNW which does support fishing opportunities downstream and boating in tidal areas.

Navigation: These two reaches are not navigable.

Recreation: These reaches, on private property, have limited recreational opportunities because of its small size.

Public Health: The water quality functions of these reaches does influence downstream areas and to that extent it may affect public health.

Significant Nexus: Based on the information provided above the ephemeral channels have a significant nexus with the physical, chemical and biological integrity of the TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
