### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** A site visit was conducted by Mrs. Vera Koskelo, Regulatory Project Manager, Maryland Section Southern. The site visit revealed that the area located within the Corps Area of Review, as identified on Enclosure 1, which is included with the associated Department of the Army determination letter, is located within an existing dry stormwater management facility. The existing facility includes a dry detention basin, water control structures, outfall structures and emergency spillways with grassed swales conveying flow into the existing basin. There is no stream channel present within the Corps Area of Review. In addition, no ephemeral, intermittent or perennial streams are identified within the Corps Area of Review on the 2014 Gaithersburg USGS Quadrangle. The Wetland Determination Data Forms (Appendix E), included with the "Joint Federal/State Application for the Alteration of any Floodplain, Waterway, Tidal or Nontidal Wetland in Maryland", dated October 14, 2014, indicate that there are no observed wetlands within the Corps Area of Review which meet all three of the required parameters, which include hydrophytic vegetation, hydric soils and hydrology. Also, according to the Hydrologic Soil Group-Montgomery County, Maryland (Watkins Meadow, Asset # 10855) soil survey information, included with the application, the soil taxonomy of the site located within the Corps Area of Review consists primarily of "Occoquan" soils

(approximately 80% of the profile), which are moderately to well drained soils and considered to be non-hydric. Based on the above information, the site located within the Corps Area of Review is determined to consist of uplands (does not consist of features which meet the definition of a waters of the United States in accordance with 33 CFR 328.3), and is not federally regulated.
