- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **A review of Google Earth aerial photographs and Anne Arundel County topographic maps, followed by Corps field review on September 23, 2014, revealed that W-1, W-3, and W-4 do not have a surface tributary connection to other Waters of the U.S. W-1 is a palustrine forested depression that has an inlet from flows contributing from the adjacent road, but no outlet and no surface water connections to Waters of the U.S. For emergent wetlands W-3 and W-4 there are no surface tributary connections to other Waters of the U.S. The Corps has determined that isolated wetlands (W-1, W-3 and W-4) are present at this site. No evidence of a connection, surface flow or other hydrologic connection to any other jurisdictional waters of the United States was observed during the Corps field review. In the State of Maryland, isolated waters are not Federally regulated because of the Wilson Case. That is 33 CFR Part 328.3(a)(3) has been removed from the Corps regulations in the Fourth Circuit. Therefore, the isolated wetlands at this site are not Federally regulated.**

SECTION III: CWA ANALYSIS

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
