The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Area of Review includes 7.3 acres adjacent to an existing stone quarry, and is shown on the plan "Aerial Map, WMQ New Milford 2 Quarry, General Permit for Bluestone (5 Acres or Less) Mining BMP-GP-105, Prepared for WM Quarries, LLC, Fox Engineering, Figures 1-3, Dated 4/10/17". The site visit revealed that the Area of Review (i.e, the proposed quarry expansion) was some highly-disturbed cleared area and an area of early successional upland forest situated on a gently sloping (4-6% slope) hillside, with stony, well-drained soils. The Area of Review was dominated by black cherry, beech, aspen, and scattered pitch and scotch pines. The Area of Review is adjacent to an active stone quarry, and very little standing water was seen at the bottom of the pit in the active quarry, at depths well below the existing surface of the proposed quarry expansion.
