AUTHORIZATION: Section 219, Water Resources Development Act (WRDA) 1992, as amended by Section 504 WRDA 1996, Section 502 WRDA 1999, and Section 5125 WRDA 2007.

TYPE OF PROJECT: Environmental Infrastructure

CONTRIBUTION TO CHESAPEAKE BAY: Contributes to achieving protection and restoration goals established by the 2009 Executive Order 13508 and the 2014 Chesapeake Bay Program Agreement to restore clean water.

PROJECT PHASE: Design/Construction

NON-FEDERAL SPONSORS: Northeast Pennsylvania counties, municipalities, or regional authorities

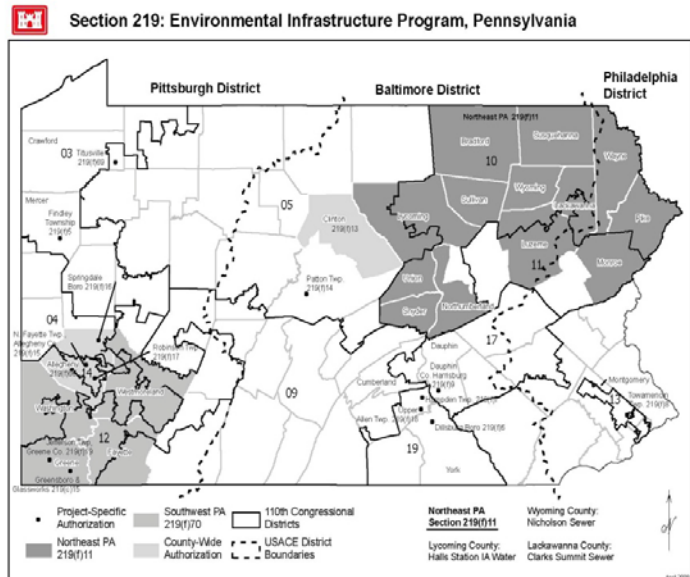
BACKGROUND: The Section 219 program provides planning, design, and construction assistance for water- and sewer-related environmental infrastructure and resource protection and development projects for local communities throughout the country. Since fiscal 2001, Congress, through the annual Energy and Water Appropriations Act, has provided \$10.5M (\$20M authorized) to assist counties located in Northeast Pennsylvania. The following projects have been completed under Baltimore District:

Halls Station Sewer Project. The project, awarded in fiscal 2003 for \$1.4M, conveys wastewater collected at Halls Station to the Montoursville Regional Sewer System Wastewater Treatment Plant - 100 percent complete.

Muncy Creek Routes 405/442 Sewer Project. The project, awarded on March 24, 2005 for \$2.2M, consists of 31,000 LF of gravity sewer, 204 LF of force-main sewer, 16 residential grinder pumps, and associated site preparation, electrical and site restoration work - 100 percent complete.

Athens Sewer Project. The project, awarded for \$1.0M, consists of 8,900 LF of gravity sewer pipeline, 620 LF 6" PVC laterals, 2,890 LF of 8" PVC force-main pipe, 220 LF of bore and encasement, a Pump Station modification, and site preparation - 100 percent complete. The Sponsor is Athens Township Authority.

Halls Station Phase IA Water Project. The project, consisting of 13,500 LF of water line and associated site preparation and restoration work, was awarded September 30, 2007 for \$1.1M - 100 percent complete. The Sponsor is the Lycoming County Water and Sewer Authority.

Clarks Summit Sewer Project. The project, consisting of replacing 2,200 LF of existing terra cotta pipe with new PVC pipe and fourteen manholes was awarded October 27, 2008 for \$724K-100 percent complete. The Sponsor is the Borough of Clarks Summit.

Nicholson Sewer Project. The project, consisting of constructing the main sewer line for Nicholson Borough, was awarded September 30, 2008 for \$2.5M - 100 percent complete. The follow-on project to construct lateral lines was awarded on February 26, 2010 for \$2.3M - 100 percent complete.

Towanda-Wysox Water Project. The project, consisting of constructing approximately 1,350 LF of water line from the Towanda Municipal Authority water system to Wysox Township, was awarded September 6, 2011 for \$1.5M - 100 percent complete. The Sponsor is the Wysox Township Municipal Authority.

STATUS: There are currently no active projects under the Section 219 Program.

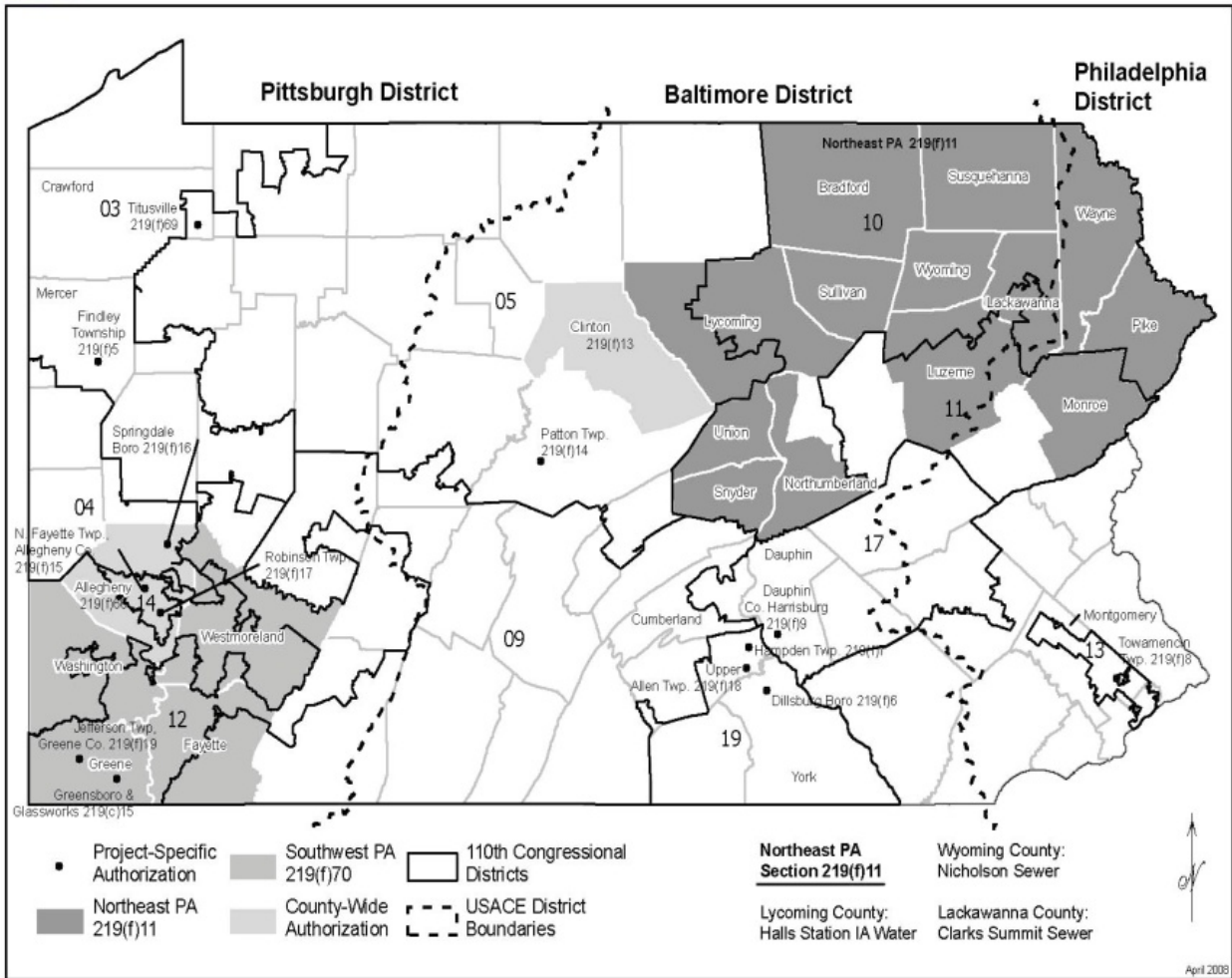
