Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **The Corps conducted a field review on 22 APR 2022, and a desktop analysis on 2 NOV 2022. During the review, three wetlands (Wetland C, T, W/X) exhibiting all three wetland indicators, including three reaches (Reach 1, 2, 3) were identified. Further, 10 isolated wetlands (Wetland D, E, F, K, Q, R, S, V, Y, Z) were identified in the Corps Area of Review. It was determined these features are non-Federally regulated, isolated intrastate waters, and there was no evidence of a connection surface flow or other hydrologic connection from the wetlands (Wetland D, E, F, K, Q, R,**

S, V, Y, Z) to other waters of the U.S. Within the Fourth District states, that includes Maryland, isolated waters are not Federally regulated due to the United States v. James J. Wilson case. That is, 33 CFR 328.3(a)(3) has been removed from the Corps regulation in the Fourth Circuit. In conclusion, the 10 isolated wetlands (Wetlands D, E, F, K, Q, R, S, V, Y, Z) at this site are not Federally regulated and are not connected to regulated waters U.S.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: Very little biological and chemical function present due to the fragmented characteristics of the wetland systems. The waters of the U.S and abutting wetland systems were observed to be flowing during the 22 APR 2022 site visit.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetlands discharge ground water seasonally, providing further evidence that these stream channels have continuous flow “seasonally”, e.g. for three months or greater during a typical year. Further, during the 22 APR 2022 site visit, waters of the U.S (Reach 1, 2, 3) and abutting wetland systems (Wetland C, T, X/W) were observed to be flowing. The flow observed in the unnamed tributaries of Cabin Branch, flows directly to Cabin Branch and into Curtis Bay which flows into a traditional navigable waterway, the Chesapeake Bay.
