

National Environmental Policy Act (NEPA)

- Environmental Assessment (EA) assesses the potential of a Proposed Action to cause environmental effects
 - EA includes brief discussion of:
 - Purpose & Need for the Proposed Action
 - Alternatives to the Proposed Action
 - Potential environmental & social impacts
 - List of agencies and persons consulted
 - Based on the EA, one of two actions can occur:
 - EA determines the action would not have significant impacts a Finding of No Significant Impact (FNSI) is issued
 - EA determines there would be significant impacts an Environmental Impact Statement (EIS) is prepared







Fort Belvoir Information

- Fort Belvoir & Fort Belvoir North Area (FBNA)
 - Provides logistical, intelligence & administrative support to Army & DoD organizations
 - Contributes to the nation's defense
 - Provides housing, medical services, recreational facilities & other support services to active-duty military and retirees in the National Capital Region
- FBNA, formerly Army Engineer Proving Ground
 - Three miles northwest of Fort Belvoir's main installation
 - Hosts National Geospatial Intelligence Agency (NGA) headquarters





Proposed Action

FBNA Distribution Center

- Construct a distribution center, approximately 525,000 sq. ft.
- Support approximately 600 additional personnel
- Enhanced security measures
- Approximately 640 cars and 12 trucks daily
- Operation hours 6am to 4pm M-F

Purpose and Need for the Proposed Action

- FBNA Distribution Center Project Purpose:
 - Build and operate a warehouse and administrative building at FBNA
 - Support delivery and receipt of materials across the National Capital Area
- FBNA Distribution Center Project Need:
 - To modernize logistical operations and incorporate safety, security, & operational features



Development of Draft EA and Schedule

- **Completed Early Public Input Period:** The Early Input Notification was sent via postal service and email to stakeholder list to solicit the early input on the Proposed Action. (19 April through 4 May 2022)
- Completed Preparation of the Draft EA: The Draft EA was prepared by an interdisciplinary team of environmental professionals. (1 April through 30 June 2022)
- Initiate 30-Day Public Review and Comment Period for the Draft EA: The Draft EA is made available for public review and comment. (30 June through 29 July 2022)
- **Preparation and Publication of the Final EA:** After the 30-day review period, all comments are addressed and incorporated into a Final EA. (30 July through 12 August 2022)





EA Analysis

Resources Evaluated for Current and Potential Cumulative Impacts:

- Land use
- Geology, topography, and soils
- *Water resources
- *Biological and Cultural resources
- Hazardous and toxic materials and waste
- Utilities and infrastructure
- *Noise
- Airspace
- Air quality
- *Traffic and transportation
- Socioeconomics, environmental justice, and protection of children

* Initiated coordination with agencies and/or conducted new surveys



Water Resources

Evaluation and Potential Cumulative Impacts:

- Water Resources include:
 - Surface Water
 - Wetlands
 - Coastal Zone
 - Stormwater
 - Groundwater
 - Floodplains
 - Resource Protection Areas (RPAs)
- Conducted wetland surveys, October and November 2021
- Project would avoid wetlands, the Accotink Creek Conservation Corridor, and RPAs
- Project would implement low impact development for stormwater








Biological and Cultural Resources

Evaluation and Potential Cumulative Impacts:

- Resources include:
 - Vegetation
 - Wildlife
 - Partners in Flight
 - Rare, Threatened and Endangered Species
 - Cultural Resources and Historic Properties
- Conducted a Forest stand delineation, August 2021
- Conducted a Habitat Characterization Survey, August 2021
- Conducted Bat presence/absence survey for the Northern Long-Eared Bat, May 2022
- Conducted presence/absence Small Whorled Pogonia survey, June 2022
- Initiated early coordination with U.S. Fish and Wildlife Service; no presence of Northern Long Eared Bat and Small Whorled Pogonia was identified
- Initiated early coordination with VA Department of Historic Resources (DHR) and the Tribal Community - received concurrence of no effects from DHR, June 2022

Noise Study

Evaluation and Potential Cumulative Impacts:

- Conducted a noise study in March 2022 which determined less-than-significant impacts on noise.
- Best Management Practices to follow include:
 - Fairfax County noise ordinance limits construction noise above 60 dBA for residential areas during weekdays.
 - Noise levels must not exceed National Institute for Occupational Safety and Health or Occupational Safety and Health Administration guidance for workers.
 - To minimize the potential adverse impact from these noises, construction vehicles would be equipped with noise dampening equipment including mufflers which would be operated according to the manufacturers' instructions.
 - Construction vehicles and equipment would be turned off when not in use for more than five minutes.
 - Construction would take place during daylight hours on weekdays, unless there is a specific action that would require working outside of this normal timeframe, such as mobilizing oversized materials or equipment to the site.






Traffic Study

Evaluation and Potential Cumulative Impacts:

- Conducted a Traffic Impact Study in March 2022 which determined negligible impacts on traffic as a result of daily commutes and operations on FBNA.
- A traffic management plan would be prepared to ensure coordination and compliance with traffic patterns during construction.
