Explain: **The upland constructed stormwater feature originates at a culvert outlet under S.R. 181 that discharges stormwater runoff from upslope development on the east edge of the Study Area. The stormwater feature was excavated in an upland and is part of an existing stormwater management system for the purposes of conveying upland storm stormwater run-off (33 CFR 328.3(b)(10). The wetland is a direct result of this feature. The on-site investigation, coupled with the use of aerial photography and various other secondary data information, showed that this upland constructed stormwater feature was not a past natural stream channel. In addition, the feature is located within a stormwater management easement shown on the mapping.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
