that exit the property and all features do not discharge water or flow to any tributaries to TNWs. Feature BON-SC-005 is a rock lined stormwater channel along a graded gravel pad that was constructed in uplands to control onsite stormwater. The stormwater channel connects to BON-S-001 and only flows during stormwater events and does not display characteristics that would qualify it as a water. This feature is fed by stormwater and is not a regulated water. BON-S-001 is an Ephemeral channel created due to erosion from stormwater runoff from the onsite gravel parking lot. This feature only flows during storm events and enters wetland BON-W-013, which is a closed depressional wetland with no out flow. Wetland BON-W-001 is a closed depressional wetland along Bonnie Drive. Like the on-site wetlands and streams on site Wetland BON-W-001 was formed as a result of historic strip mining of the review area. The wetland is emergent and provides low-minimal function and services to the watershed. The wetland does not have hydrologic connection to a tributary and does not have a significant nexus to a regulated feature. Wetlands BON-W-003 and BON-W-002 are PEM wetlands located in the middle of the review area. These wetlands are also closed depressions that do not have a connection to any other resources. Overall, Wetlands BON-W001, 002 and 003 provide minimal functions and services, such as stormwater retention and pollutant retention. BON-W-013 is a PEM wetland that receives hydrology during storm events from Ephemeral Channel BON-S-001. This wetland is a closed depressional wetland that does not have surface flow exiting the wetland and does not have connection to any other features or tributaries. In summary all wetlands within the review area are isolated, closed depressional wetlands that provide low-minimal functions and values. All stream/stormwater channels are fed via stormwater and do not provide significant functions and services to the overall watershed..

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
