C. PROJECT LOCATION AND BACKGROUND INFORMATION: The project is located at 625 Main Street, Greensboro, Caroline County, Maryland. The property is approximately 39.7 acres currently owned by the Board of Education of Caroline County. The project wetland is located along the northeast edge of the of the property in an agricultural field. It is a depressional wetland that has no discernable surface connection to any traditionally navigable water (TNW). Wetlands 1 and 2 are located the forested area that covers the west most side of the property. These two wetlands are also depressional features that do not have surface connections to any TNW. The closest TNW is the Choptank River, approximately 2,500 feet east of the project wetland.

- ☒ Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The project Wetland is a .75 acre depression on the project site. It is bordered by upland croplands to the west, north and east and a solar array to the south and east. The topography indicates that the wetland would drain to the southeast where the solar array is now located. During a site visit on March 21, 2019, rainfall contributed to 4 - 12 inches of standing water within the wetland. The standing water extended to the ground below the solar array where it was directed via man-made swale to an adjacent drainage ditch. The drainage ditch runs along the southern border of the Solar array. This Ditch is approximately 2 feet lower in elevation than the solar array and adjacent field and serves as drainage for the area to the west and south. Water flow within the ditch was not observed during the site visit. Relatively large rainfall was being experienced during the time of the site visit and in the 24 - 48 hours leading up to the visit. Wetlands 1 and 2 are depressions located in the forested area on the western side of the property. They are 1.13 and 1.08 acres respectively. Wetland 1 is contained entirely on the property, while Wetland 2 expands west to the adjacent cleared property. Both wetlands are surrounded by upland areas. During the March site visit surface water between 4 and 18 inches deep connected these wetlands. The water was completely contained within the depression areas with no drainage features directing the water away from the wetlands. On April 3, 2019 another site visit was conducted. The surface water level had dropped by 4-10 inches depending on the location within the site. There were no longer connections between the Project Wetland and the area between the solar array. Equipment tracks from recent farming activities were present around the edge of the wetland to the fence around the solar array. No discernable drainage features existing between the wetland and the solar array. The surface water that was observed during the April 3rd site visit was a result of overland sheet flow. Wetlands 1 and 2 no longer had surface water between them.

No relatively permanent waters (RPWs) were identified on the property. Therefore none of the wetlands are adjacent to or abutting an RPW. The closest TNW is the Choptank River. The Project Wetland and Wetlands 1 and 2 fall within the drainage area of an unnamed tributary that lies approximately 1,300 feet east of the Project Wetland. Surface water hydrology connections only exist via overland sheet flow. These connections can be observed after heavy rainfall. Within days after a heavy rainfall these connections are severed. The ditch that runs along the southern edge of the solar array conveys water towards the unamed tributary. No distinct drainage features could be found to show that a continuous path exists from the wetlands to the unamed tributary. Therefore, a significant nexus determination could not be made and the Project Wetland, Wetland 1 and Wetland 2 are all considered intrastate, non-navigable, isolated waters. As such the Corps would not assert jurisdiction over these aquatic resources.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
