Aerial photography shows that at least as far back as 1947 the area, where the existing drainage tiles are located, had been manipulated to allow for farming. Ground water, including groundwater drained through subsurface drainage systems like tile drains used in agriculture, are excluded (Exclusion (b)(2)) if replaced at the same location and no additional drain tiles are installed. |
