C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

 Tributaries of TNWs where tributaries typically flow year-round are jurisdictional. Provide data and rationale indicating that tributary is perennial: The Corps conducted a field review on August 16, 2021. During the site visit, water was flowing in the channel and there was a clearly defined OHWM and bed and bank. The perennial stream channel is named Bear Branch and is located in the Bear Branch Watershed, a tributary to the Severn River and ultimately the Chesapeake Bay. Bear Branch is classified as a Use I waterway according to CoMar 26.08.02.08. The stream is relatively straight with few meanders within the Corps area of review and has an estimated width of 6 feet from bank to bank. The stream is located adjacent to a palustrine forested wetland within the Corps area of review. The stream channel is shown on the NWI Map, USDA NRCS Web Soil Survey, and as a blue line on the USGS National Hydrography Dataset (NHD).

- Tributaries of TNW where tributaries have continuous flow “seasonally” (e.g., typically three months each year) are jurisdictional. Data supporting this conclusion is provided at Section III.B. Provide rationale indicating that tributary flows seasonally: During the site visit, portions of the intermittent stream channel contained flow and there was a clearly defined OHWM and bed and bank. Further, a palustrine forested wetland, exhibiting all three wetland characteristics was identified at the top of the intermittent stream channel. Wetlands discharge ground water seasonally, providing further evidence that this intermittent stream channel has continuous flow “seasonally”, e.g. for three months or greater during a typical year. The intermittent stream channel directly flows into the perennial stream channel, Bear Branch, identified above.

Provide rationale indicating that wetland is directly abutting an RPW: During the site visit on August 16, 2021, a palustrine forested wetland was observed directly abutting (i.e., touching) an intermittent stream channel that provides direct surface flow to Beach Branch, a RPW that flows directly or indirectly into a TNW, the Chesapeake Bay. The wetland exhibited all three wetland characteristics, i.e. soils, hydrology and vegetation. Aerial imagery and the NWI Map display the palustrine forested wetland abutting Bear Branch. Further, local LiDar topographic maps show topographic relief that would support the presence of PFO wetlands.
