#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

Wetland size: Approximately 4.81 acres

Wetland type. Explain: Primarily forested wetlands that have been highly disturbed historically. Varying states of recovery for the most part and subject to non-native invasive infestation.

Wetland quality. Explain: The subject wetlands continue to perform various functions but at a lower capacity due to past disturbances and landuse. The wetlands provide habitat for a variety of wetland and non wetland dependant species. However, both wildlife habitat and water quality functional capacity are decreased due to the referenced past disturbances. Namely, historic ditching has changed the flow and circulation of waters within this area. However, some of the larger wetlands on site have recovered to varying degrees as ditches and other disturbances become less effective over time. The wetlands would appear to score moderately using MD Wetland Assessment Methodology, although an official assessment was not performed. The wetlands have poor buffer quality as they are surrounded by various development and or adjacent riparian areas are fragmented. The biotic structure of the wetlands is pretty good having moderate topographic complexity, physical structure, and edge complexity. As stated, the soils are generally in some advanced state of recovery suggesting carbon storage and water quality functions such as denitrifications are ongoing. The number of aquatic resources within a 1000 feet suggest that opportunities are present for movement of various species increasing aquatic context despite some disconnection by roads.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Provide rationale indicating that tributary flows seasonally: The primary water source of the wetlands is groundwater as evidenced by numerous discharge points on both the upper and lower slopes. At the time of observation, numerous braided flow patterns (wetland drainage patterns) were evident. Furthermore, the wetlands are in backslope landscape position which often suggests long duration or perennial discharges. Soil profiles indicate a fluctuating water table (depleted matrices and common redoximorphic concentrations and also organic

accumulation in the lower areas supporting extended residence time of water and eventual water movement to the stream for augmenting stream flow. The watershed is of moderate size and contours suggest high potential for numerous groundwater discharges as evidenced by many topographic crenulations to the north and west of the site. Furthermore, both USGS and NHD have mapped the site as blue line or a perennial system. These factors along with observations of regular flow in the channel of the main tributary to Broad Creek indicate that the system is at least intermittent, and possibly even perennial. Strong morphological features are observed in the tributary such as discussed earlier in this report (B.1).
