### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Provide rationale indicating that wetland is directly abutting an RPW: During the site visit on December 17, 2021, a palustrine forested wetland (PFO) exhibiting all three wetland characteristics, i.e. hydric soils, hydrology, and hydrophytic vegetation, was observed on the east side of the property, within the Corps Area of Review. The PFO wetland drains in an easterly direction through a culvert under Belhaven Avenue and directly into an off-site PFO wetland, i.e. the two PFO wetlands on either side of Belhaven Avenue have a direct hydrologic connection. These wetlands were at one time a single wetland system and were fragmented by Belhaven Avenue, however, the hydrologic connection has been maintained through the existing culvert under Belhaven Avenue. The off-site PFO wetland on the east side of Belhaven Avenue continues to drain east and directly abuts (i.e. touches) an off-site perennial stream channel (Back Creek) that provides direct surface flow to a TNW, the Chesapeake Bay. Back Creek is classified as a Use I waterway by the Maryland Department of the Environment (COMAR 26.08.02.08) and is also shown as a blue line on aerial imagery and on the NWI wetland map for this section of Anne Arundel County. USGS topographic maps show topo lines that extend just west of Belhaven Avenue, further supporting the presence of a PFO wetland system on either side of Belhaven Avenue with connection to an off-site perennial stream channel (Back Creek).
