- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: **The Corps conducted a field review on January 26, 2022, and a desktop analysis on September 29, 2022. During the reviews, one stormwater management facility was located near the eastern portion of the Corps Area of Review (AOR). During the Corps site visit and desktop analysis, it was determined that the stormwater management facility was constructed in uplands sometime between 2006 and 2007 for the purpose of stormwater flow and retention.**

The NRCS soil survey shows mapped Sassafras and Croom Soils, which are well drained and have 5% hydric Zekiah inclusions typically found in drainageways, floodplains and drainhead complex landforms. NRCS soil survey also showed mapped Patapsco-Fort mott complex soils, which are somewhat excessively drained and have 0% hydric inclusions. The Corps reviewed the USGS topoquad maps to ensure that the stormwater management facility was not an impoundment of waters of the U.S. Topographic quads from 2007 show no contour lines that would suggest the presence of any regulated resources above or below the stormwater management facility. Further, NWI maps do not show any potentially jurisdictional features above or below the facility. Based on the Corps field review and the data presented above, the stormwater management facility is not naturally occurring, was constructed in uplands, and is not an impoundment of waters of the U.S.; therefore, the Corps has determined that the review area contains no Federally regulated waters of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
