C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Corps received a No Permit Required (NPR) request from SGC Power LLC in December 2021. The Corps reviewed the supporting data in the NPR request for the 3297 Grafton Street, Manchester, Carroll County,

Maryland property. The supporting data includes data sheets prepared on behalf of the applicant, USDA NRCS Soil Survey, aerial photography, and several other documents listed in Section IV(A). On May 4, 2022 the Corps visited the site and walked the Limit of Disturbance (LOD) of the proposed solar facility. The Corps did not observe any wetlands or waters of the U.S. within the proposed solar facility LOD. The Corps observed that the current land use is agricultural and to the southwest of the LOD there appears to be wetlands and waterways associated with Georges Run. In conclusion, based on the available resource documentation and the Corps field observations during the May 4, 2022 site visit, the Corps has determined the area of review includes dry land and no jurisdictional waters of the U.S.
