C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Using aerial imagery and mapping services from sources such as the State of Maryland Watershed Resources Registry and the USGS Stream Stats pages, the wetland observed within the Corps AOR extends outside the Corps AOR where it abuts or directly touches an unnamed tributary to Rogue Harbor Branch, an RPW (attachement 1). The unnamed tributary then flows under Annapolis Road in a southerly direction where it enters a stormwater facility, then exits at the south end of the pond and continues to flow in a southerly direction until its confluence with the Patuxent River.
