Explain: **The Corps received an application for a Department of the Army permit to construct a single residential dwelling, driveway and associated improvements on the west side of Martingham Drive, St. Michaels, Talbot County, Maryland. The Corps conducted a site visit on May 27, 2022. During the review, one depressional wetland system, exhibiting all three wetland indicators, was identified in the Corps Area of Review. During the Corps site visit, there**

was no evidence of a connection, surface flow, or hydrologic connection from the wetland system to any downstream water of the U.S, nor is the wetland adjacent, i.e. bordering, contiguous or neighboring a traditional navigable water. Therefore, the Corps has determined that the single depressionnal wetland within the Corps area of review is isolated, not jurisdictional, and not federally regulated. Within the Fourth District Court states, that includes Maryland, isolated waters are not Federally regulated due to the United States v. James J. Wilson case. That is, 33 CFR 328.3(a)(3) has been removed from the Corps regulation in the Fourth Circuit. In conclusion, the isolated wetland on this site is not Federally regulated.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
