During the review, a drainage swale originating from a septic system was identified near the center of the area of review and a stormwater drainage swale was identified along the western border of the area of review. The two drainage swales do not have a bed and bank or an ordinary high water mark and are therefore not considered Waters of the U.S.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The perennial stream channel is named Picture Spring Branch and is classified as a Use I waterway according to CoMar 26.08.02.08. The stream is relatively straight with few meandors within the Corps area of review and has an estimated width of 6 feet from bank to bank. The stream is located within a palustrine forested wetland within the Corps area of review. The stream channel is shown on the NWI Map, USDA NRCS Web Soil Survey, and as a blue line on the USGS National Hydrography Dataset (NHD).
