C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The installation of the fiber optic cable would originate near the intersection of U.S. Route 50 and Maryland Route 16, continues west along Maryland Route 16 to Bay Shore Road via Hooper Neck Road, Dorchester County, crosses the Chesapeake Bay to Cove Point, Calvert County, follows Maryland Route 497 to Routes 2 and 4 South, and terminates at Maryland Route 235 and Maryland Route 246 in St. Mary's County, Maryland. The proposed project is located within the tidal waters of Church Creek, Woolford Creek, Parsons Creek, Slaughter Creek, Chapel Cove, Saint John Creek, the Chesapeake Bay, the Patuxent River, and Town Creek. The new cable would be installed on the bridges within existing conduit, or, be directionally bored beneath wetlands and Section 10 waterways. There will be impacts to waters of the United States, pursuant to Section 10 of the Rivers and Harbors Act and Section 404 of the Clean Water Act for the Chesapeake Bay crossing.
