**C. PROJECT LOCATION AND BACKGROUND INFORMATION:**

The extent of the Corps' study area for this approved JD was designated as the black dashed line depicting the limit of disturbance as shown on the site plan entitled: "MARSHALL RIDGE #2 OPERATION SMP No. 17110107 Site Map - U.S. Army Corps of Engineers", dated April 2011, last revised December 2012, and prepared by Geotech Engineering, Incorporated.

The mining operation area has not been abandoned and the reclamation has not been completed.

The existing microtopography within the study area is a result of previous surface coal mining disturbances approximately 40 years ago. The single emergent wetland (93 square feet in size) that exists within the study area is a by-product of man-made actions upon uplands. Because of past earth disturbances, most of the study area was left without positive surface drainage with the only sources of hydrology being provided by surface storm water and ground seeps that were exposed by previous surface coal mining activities. Stormwater and/or seep discharges have pooled in this area for a sufficient time to allow for early successional hydrophytic vegetation to become established into this wetland.

**C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
