- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: Stream #1 is a perennial waterway that runs in a north to south direction through the study area. Stream #1 flows several hundred feet, once it leaves the project study area, and discharges into a series of five sinkholes called "The Maple Hill Sinks or The Sink". The sink holes range in size from 0.5 to 4 acres over a distance of 1.4 miles. I can find no documentation that states to what waterway the sinkholes discharge. In addition, I spoke to a property owner who has a portion of the sinkhole on their property. She stated that several years earlier a team of divers dove in the sinkholes to determine where they drained to. They could not find the outlet. Thus Stream #1 has no surface connection to any waters that flow directly to navigable waters. In addition, wetlands 2-5 abut Stream #1 just prior to entering the sinkholes. Stream #2 flows into Stream #1 just prior to entering the sinkholes. Stream #2 has wetland 1 & 6 directly abutting it. During my field view, I observed wetland 1-6 directly abutting Streams 1 & 2. The destruction of these waters (Streams 1&2 and Wetlands 1-6) would not appear to effect the chemical, physical, and biological integrity of a TNW (no significant nexus to a TNW), since it has no surface connections to waters.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
