C. PROJECT LOCATION AND BACKGROUND INFORMATION: This jurisdictional determination does not set forth the jurisdictional status of each individual water and/or wetland crossed by the proposed fiber optic line. Instead it establishes that the nature of the work described by the applicant does not result in the discharge of dredged and/or fill material into a water of the United States and does not result in any structures and/or work within a navigable water of the United States.

The fiber optic line will be constructed in an existing railroad bed. The physical bed itself is uplands. The bed does cross numerous watercourses. However, these watercourses will be crossed utilizing directionally drilling under or burying the cable ovetop of existing culverts that convey the various watercourses under the railroad tracks or attaching the conduit to existing bridge structures that carry the railroad over certain waterways. The act of burying the cable ovetop of the existing culvert is work in uplands and does not result in a discharge of dredged and or fill material into waterway flowing through the culvert pipe beneath. The crossing of the navigable water will be accomplished by attaching the conduit to the existing bridge structure.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
