C. PROJECT LOCATION AND BACKGROUND INFORMATION:

The project is located off of Runway 22, at the Wilkes-Barre Scranton International Airport, an active airport located off of Interstate I-81, in Pittston Township, Luzerne County and Moosic Borough, Lackawanna County, PA.

The review area associated with this JD is limited to the "Approximate Study Area" as depicted on the approved plan entitled: "Wilkes-Barre/Scranton International Airport Wetlands and Surface Waters Map", prepared by L.R. Kimball, A CDI Company, undated.

The two isolated wetlands (Wetland W01 and Wetland W03) are the subject of this JD. Both wetlands are classified as palustrine, emergent (PEM) wetlands with a high groundwater table as the primary hydrology source. See item III (F) below for details.

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Amy Elliott (Corps) has reviewed current on-line aerial photography resources including Google Earth; ArcGIS Explorer; and Penn Pilot. In addition, an on-site investigation was conducted on 10/22/12 - 10/24/12 by L.R. Kimball staff. Two (2) PEM wetlands were identified within the study area. Wetland W01 is a PEM wetland that is bordered by the Runway 22 fill slope to the west and a forested strip to the east where it extends to the east outside of the Airport fence and property. Wetland W01 is an isolated depressional wetland approximately 0.22 acres in size. Wetland W03 is a PEM wetland bordered by an old roadbed to the west and forest to the east and is located to the east of Wetland W01. Wetland W03 is an isolated depressional wetland approximately 0.05 acres in size. Wetland W01 and Wetland W03 were confirmed to be isolated with no surface connection, directly or indirectly, to relatively permanent waters (RPW) or traditional navigable waters (TNW). These areas are not traditional navigable waters, and are intrastate waters/wetlands.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
