Explain: The "Study Area" contains two (2) stream channels, identified as Watercourse A and Watercourse I. Both Watercourse A and Watercourse I are identified as non-RPWs. In the "Study Area", Watercourse A begins at a culvert which is located under Cahill Road. Watercourse A extends approximately 800 linear feet down slope from the culvert. Watercourse I is a side channel flowing from Watercourse A and begins at the downstream reach of Watercourse A. Watercourse I extends approximately 100 linear feet from its confluence with Watercourse A. Both channels consist of a defined bed and bank with cobble, gravel and mud substrate. At the downstream reaches of both Watercourse A and Watercourse I, the bed and bank features dissipate and are no longer visible, the features exhibit no observable hydrologic connection to a waters of the United States, have no significant nexus to a TNW, and do not meet the definition of a waters of the United States in accordance with 33 CFR 328.3. Therefore, Watercourse A and Watercourse I are considered to be isolated channels, are not jurisdictional waters of the United States, and are, therefore, not subject to federal regulation under Section 404 of the Clean Water Act.

C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
