**B. CWA SECTION 404 DETERMINATION OF JURISDICTION.**

There **Are** "waters of the U.S." within Clean Water Act (CWA) jurisdiction (as defined by 33 CFR part 328) in the review area. [Required]

Stream 2 begins at the southern edge of Wetland 4. Stream 2 flows in a southern direction where it then makes a sharp right under an existing railroad bed through a culvert pipe. Once it outlets, wetland 5 begins and is located on both sides of Stream 2, it flows approximately 800 feet where it runs past wetland 6 (which is abutting stream 2). Stream 2 then flows under River Road, via culvert pipe. Once on the east side of River Road, it flows approximately 100 feet until it reaches the West Branch of the Susquehanna River (Traditional Navigable Water). Wetlands 2, 3 and 7 are located within the 100 year floodplain of the West branch of the Susquehanna River and considered adjacent to a TNW.

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Wetlands, 8 -10 are intrastate wetlands that are depressional located on relic logging roads and/or resulted from tractor ruts or 4 wheeler activity. Stream 1 and 3, and wetland 1 and 13 are intrastate waters and wetlands. Wetland 13 is on the western side of US Route 15. Wetland 13 is part of a large wetland on the west side of US Route 15 where stream 3 begins. Stream 3 flows in an eastern direction under US Route 15. The channel runs along SR 15 in a northern direct for approximately 200 feet and makes a sharp right where it then bisects the "Area of Investigation" running just south and parallel to Commerce Drive. Ponds 1 and 2 are two stormwater ponds previously constructed on stream 3. Once stream 3 flows into Pond #2, it discharges into an overflow pipe and runs several hundred feet through a culvert pipe where it discharges on the east side of a ridge that runs in a north-south direction through the "Area of Investigation". At the outlet of the culvert the stream is labeled by the consultant as stream 2 (but stream 1 and 2 are the same). The channel is evident for approximately 100 feet and then is lost as flow appears to go subsurface. Wetland 11 is in an area that appears to have been excavated in the past. Wetlands 12, 14, 15A and 15B and on-line Stormwater Ponds 1 and 2, located on stream 3, are related to active stormwater basins that were constructed for past development and has no visible surface connection to waters of the United States.

The destruction of the above mentioned areas would not affect interstate or foreign commerce. These areas are not used by interstate or foreign travelers for recreational purposes, fish or shellfish are not taken and sold in interstate or foreign commerce, and are not currently used for industrial purposes in interstate commerce. These wetlands, streams and ponds have no surface connection nor are they adjacent to any waters that flow directly to navigable waters. During my field view no surface outlets were identified for these wetlands. The destruction of these wetlands, ponds and stream channels would not appear to affect the chemical, physical, and biological integrity of a TNW (no significant nexus to a TNW), since they have no surface connection to waters that flow to navigable waters nor are they adjacent to any of these waters.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for

analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- **OBJECT:** If you object to the permit (Standard or LOP) because of certain terms and conditions therein, you may request that the permit be modified accordingly. Your objections must be received by the Baltimore District Engineer within 60 days of the date of this notice, or you will forfeit your right to appeal the permit in the future. **C: PERMIT DENIAL:** You may appeal the denial of a permit under the Corps of Engineers Administrative Appeal Process by completing Section II of this form and sending the form to the North Atlantic Division Engineer, ATTN: CENAD-PD-PSD-O, Fort Hamilton Military Community, Building 301, General Lee Avenue, Brooklyn, NY 11252-6700. This form must be received by the North Atlantic Division Engineer within 60 days of the date of this notice with a copy furnished to the Baltimore District Engineer.
