The property is comprised of an upland mixed hardwood forest, as documented in the Wetland Delineation Report dated April 29, 2016. A storm drain pipe and outfall was identified through the central portion of the site. Three storm

drain inlets in an adjacent recreational baseball field, to the west of the site, collects runoff, directing it into a storm drain system which outfalls in the central portion of the site. A man-made, stone rip-rap conveyance channel constructed in uplands, directs stormwater from the outfall pipe towards an existing noise barrier wall constructed along the western edge of the property and along I-97. The runoff washes under the sound wall and into a heavily rip-rapped roadside ditch draining along Interstate 97. This roadside ditch conveys water in a southerly direction eventually draining into an unnamed tributary to Sawmill Creek. With reference to the 1987 Corps Wetland Delineation Manual and the Corps of Engineers Atlantic and Gulf Coastal Plain Regional Supplement, there were no signs of wetland hydrology and no waters of the U.S. with ordinary high water mark identified in the area of review. The vegetation within the area of review was dominated by upland mixed hardwood forest, FACU and UPL plant species. Three soil types are mapped on or within close proximity to the subject property. None of the soil mapping units are considered to be hydric. As a result of the site visit, all three parameters were not present, therefore, it has been determined that there are no waters of the U.S. including wetlands, located on the site.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

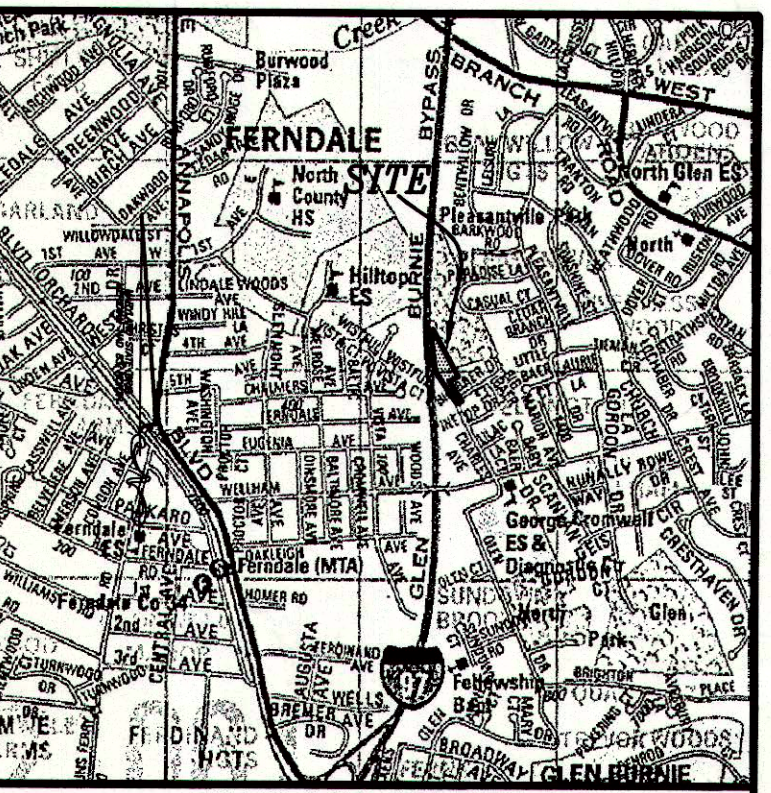
