### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The UNT discharges from the wetland, and is then entirely contained, within a concrete outlet structure and corrugated metal culvert within the storm water management basin, and then to a 5'x 5'-6" box culvert and headwall/endwall structure road crossing under Susquehanna Trail. The tributary then daylight to the surface. The UNT to Deer Creek typically flows seasonally as determined trough: a) multiple observed flow events over 20 years, b) water staining on storm water management basin concrete outlet structure and corrugated metal culvert, c) iron deposits, d) historical aerial photograph data over multiple years, and e) the presence of *Nasturtium officinale* (watercress, OBL) growing within the active stream channel downstream of the Susquehanna Trail road crossing. It is believed by the Corps that the existing storm water detention basin was constructed within an area that originally contained both wetlands and a stream channel. No records were found in this office authorizing the work. Data is not included in Section III.B and Section III.D.2 because the ordinary high water mark (OHWM) of the seasonal tributary with the review area is entirely enclosed as previously discussed. However, the enclosure of the stream does not sever the surface tributary connection of the UNT to Deer Creek to TNW's. The UNT to Deer Creek flows to Deer Creek (interstate waters), which flows to the Susquehanna River (TNW, navigable waters of the United States).
