MEMORANDUM FOR RECORD

SUBJECT: United States Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023), 1 NAB-2023-00450-P12 (Coal to Solar Phase II)

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

The review area is limited to only to Wetlands AA, AB, and AC. The center of the three wetland areas is located at Latitude: 40.907639/Longitude: -76.005555.

 - i. Wetland AA is located at the bottom of an old mining pit. The pit is surrounded entirely by high walls several hundred feet high. Wetland AA is POW with wetlands surrounding the outer edge of the open water. Wetland AA is 1.09 acres in size and is located at center coordinates (Latitude: 40.907639, Longitude: -76.005555).
 - ii. Wetland AB is a 0.15 acre POW/PEM wetland. Wetland AB has a surface connection to Wetland AC.
 - iii. Wetland AC is a PEM wetland that is 0.46 acres in size and is located at center coordinates (Latitude: 40.906889, Longitude: -76.005846). Wetland AC is located at the top of the highwall. It flows down the high wall to wetland AA. This was verified in the field during my field view of May 8, 2024.

These three wetlands have no surface connection to waters that flow to a navigable water.
