MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023), 1 NAB-2024-00505-P12 (Rapid Response Quarry Fill AJD).

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

The 2.9 acre area of investigation site is located 0.9 miles west of the center of Annville, on the south side of US Route 422, in Annville Township, Lebanon County, Pennsylvania (Latitude 40.325734/-76.531911). The site includes a 1.18 acre quarry pit, surrounded by US Route 422 to the north and maintained commercial landscape surrounding the remaining areas.

 - a. The field view was completed on November 14, 2024.
 - b. The Pennsylvania Wetland Resource Registry was used for the National wetland inventory, Lidar, Black and White Aerials 1937, 1950, 1956 and color 93 & 95, Modeled Wetlands, NRCS Soils Mapping, Topo Graphic Map. I utilized Google Map's for street view photos.
- 10. OTHER SUPPORTING INFORMATION. Within the of investigation, in addition to the quarry pit, the surrounding area was investigated to determine if wetlands were present. This area was determined to be uplands. It lacked hydric soils, any primary or secondary hydrological indicators and the vegetation was dominated by facultative upland vegetation.
- 11. NOTE: The structure and format of this MFR were developed in coordination with the EPA and Department of the Army. The MFR's structure and format may be subject to future modification or may be rescinded as needed to implement additional guidance from the agencies; however, the approved jurisdictional determination described herein is a final agency action.
