# MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023), 1 NAB-2025-60548-M53 (KRM Development /AJD)<sup>2</sup>

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>3</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>4</sup>

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>5</sup> the 2023 Rule as amended,

- 3. REVIEW AREA. The property is located at Lot 5 of the Chesapeake Bay Business Park, Queen Anne's County, Maryland and is bounded to the north and west by riparian forest, to the south and east by developments and a stormwater pond. The site is in the Cox Creek-Eastern Bay watershed<sup>6</sup> (HUC: 020600020607), approximately 19,985-acres (31.22 square miles) in drainage area. The review area is approximately 10.55-acres and is primarily an open field with a large riparian forested area along the north and east edge of the property. The site has no ditches, but contains two small, palustrine emergent (PEM) wetlands located in the open field. A dirt road/trail separates the small non-tidal wetlands from the riparian forested area. The project site is the location of a proposed commercial/industrial development.

This wetland meets the standard 3 parameter approach required by the 1987 Manual and Atlantic and Gulf Coastal Plain Regional Supplement but does not have a continuous surface connection to a jurisdictional feature.

- a. Site Visit 17 September 2024: Ms. Noreen Davis (Davis and Associates) and Ms. Jaclyn Kelleher (USACE) participated in a site visit to verify Davis and Associates' field delineation of the site. An additional site visit was conducted by M. Jaclyn Kelleher on 09 May 2025 once an AJD was requested by the applicant in order to confirm jurisdictional status of the features.
- b. Plan Sheet dated 5 February 2025: USACE was provided with a plan sheet prepared by Davis, Moore, Shearon & Associates, LLC dated 5 February 2025 with the results of the field delineation. The original plans, wetland delimitation and wetland data forms were also provided in the Joint Permit Application provided on 17 April 2025.
- c. Desktop Review: Desktop information reviewed included mapped wetland/streams feature via online geographic information systems (GIS), historic aerial imagery (1992 to present), United States Fish and Wildlife Service National Wetland Inventory (USFWS NWI) Maps, and United States Geological Survey (USGS) Stream Stats Webpage.
