The United States Department of the Army (Army) wishes to initiate formal consultation on the Utah Land Exchange Project. The National Security Administration is proposing a land exchange between the U.S. Army Corps of Engineers (Corps) and Utah Department of Transportation (UDOT) (Project). The Project is located near Lehi in Utah County, Utah. The project is a federally funded undertaking; therefore, the Corps is responsible for complying with Section 106 of the National Historic Preservation Act (NHPA) (54 USC §306108). The Sacramento District (SPK) is providing technical assistance for NHPA compliance on behalf of the Corps.

As part of this undertaking, the USACE conducted a records and literature review for the parcels to be transferred to the State. The literature review indicates that eight sites are located within the parcels to be transferred out of Federal control. Of these eight sites, five have been previously determined eligible for the National Register of Historic Places, though not formally evaluated. Transferring properties out of Federal control with known sites is considered an adverse effect, "without adequate and legally enforceable restrictions or conditions to ensure long-term preservation of the property's historic significance," (36 CFR §800.59(a)(2)(vii)).

After review of the results of the records and literature review, the USACE reached a determination of No Adverse Effect to historic properties. This finding is based on the fact that under State law (Utah Code 9-8-404), the State is required to afford historic properties considerations prior to conducting an undertaking. Utah Code provides legally enforceable restrictions which will ensure long term preservation of historic properties.

The USACE has satisfied the public outreach requirements of Section 106 through contacting previous landowners, authorized users, and State and local government entities. No cultural resource issues, concerns, or problems have been identified during outreach and opportunities for comment. Furthermore, Native American consultation was initiated by written notice to Native American Tribes.

Notice and preparation of the EA for the exchange will be posted on USACE's Military Projects website: https://www.spk.usace.army.mil/Missions/Military-Projects/. Further notice will be provided to all of the above-noted parties when the EA is completed and at such time the USACE reaches a favorable decision to complete the exchange, pursuant to the regulations at 43 CFR 2200.7-1.

We request your agency's formal concurrence to our determination of No Adverse Effect for this undertaking.
